If one or more incumbents have not filed a Declaration of Candidacy by 5:00pm August 12, 2016, any person other than the incumbent shall have until 5:00pm August 17, 2016 to file a Declaration of Candidacy. In the event that there are no nominees or an insufficient number of nominees for each office to be filled and a petition requesting an election has not been filed, an appointment to fill such elective office(s) shall be made pursuant to California Elections Code section 10515.
