## **AGREEMENT, WAIVER, AND RELEASE**

I have carefully read the description of RECREATIONAL class(es), program(s) and activity(ies) (collectively referred to as "RECREATIONAL ACTIVITY") for which I am registering, and in consideration for being permitted by the Chico Area Recreation and Park District (hereafter referred to as "CARD"), to participate in the RECREATIONAL ACTIVITY and as described in the Activity Guide, flyers, correspondence, newsletters, website, text, social media, and/or e-mail. I for myself, personal representative, assigns, heirs, and next of kin, hereby waive, release and discharge any and all claims for damages for personal injury, death or property damage which I may have, or which may hereafter accrue to me, as a result of participation in said RECREATIONAL ACTIVITY. I certify and represent that I am in good health and physically able to participate in said RECREATIONAL ACTIVITY. I fully understand the RECREATIONAL ACTIVITY involves risks, and I fully accept all such rights and responsibilities for losses, costs, and damages I incur as a result of my VOLUNTARY participation in the RECREATIONAL ACTIVITY. This release is intended to release and discharge in advance CARD (its directors, officers, employees, volunteers, and agents) from any and all liability arising out of or connected in any way with my VOLUNTARY participation in said RECREATIONAL ACTIVITY. It is understood that this RECREATIONAL ACTIVITY involves an element of risk of accidents INHERENT TO THE RECREATIONAL ACTIVITY, and knowing those risks, I hereby VOLUNTARILY assume those risks.
